The prices for the services provided are governed by the valid price list. The patient undertakes to pay a fee for the services provided in the amount according to the current price list in cash. The price list is available on the website of the ENT clinic and in written form at the ENT clinic. The provider is entitled to collect a deposit from the patient for planned procedures. In case a patient doesn't show up at the arranged meeting without a previous excuse, the provider will charge a penalty in the amount specified in the price list.
